EXPLANATORY NOTES

Class D Exemption - Property Left Empty By A Person Detained Elsewhere

Who can apply?

Technically the person who is liable to pay the council tax needs to apply for this exemption. Due to the nature of the exemption, it might be that in practice it is the prison, social worker or relative provides the details of the person detailed.

When will an exemption be awarded?

If a property is left empty because the occupant is detained then it will usually be exempt from council tax.

Exemption Criteria

An exemption will apply if the usual occupier is:-

- Detained in prison or hospital by order of a court
- Detained under the mental health act 1983
- Detained under the deportation provision of immigration act 1972
- Imprisoned, detained or in custody for more than 48 hours under the army act 1955, the air force act 1955 or the naval discipline act 1957.

This exemption will not apply if a person is in police custody before their first court appearance or they are detained for non-payment of council tax or a fine.

What happens next?

In order to apply for this exemption download the attached form, complete & return. Once your application and any supporting evidence is received, your application with the supporting evidence will be assessed and if you are successful we will issue a reduced Council Tax bill.

Appeals

If the Council decides not to award a discount you can appeal in the first instance to the Council Tax office within 28 days of notice of the decision stating your reasons. However you may not appeal against the amount of the discount.

PLEASE NOTE:

Making an application for a discount is not grounds for non-payment of Council Tax. Payment must be made in accordance with the bill already issued until you have received confirmation that the request has been granted.
