EXPLANATORY NOTES

Exemption Class S – Dwellings occupied only by persons aged under 18

Who can apply?

The person who is liable to pay the council tax needs to apply for this exemption.

When will an exemption be awarded?

An exemption may be awarded on receipt of an application and any evidence that the occupiers are under the age of 18.

Exemption criteria

To qualify these conditions must be met:

Properties solely occupied by under 18 year olds are exempt and consequently, no liability falls on the owner of the property in these circumstances.

What happens next?

Once we receive your application with evidence that you are under the age of 18, i.e. a copy of your birth certificate then we will make an assessment any evidence or a visit has been made we will make an assessment and if you are successful, if you are successful then the council tax will be placed in the name of the owner of the property but no charge will apply. If you are unsuccessful a letter will be issued explaining the reasons why.

Appeals

If the Royal Borough of Greenwich decides not to award an exemption you can appeal in the first instance to the Council Tax office within 28 days of notice of the decision stating your reasons. However you may not appeal against the amount of the discount.

PLEASE NOTE:

Making an application for an exemption is not grounds for non-payment of Council Tax. Payment must be made in accordance with the bill already issued until you have received confirmation that the request has been granted.
