## VCS COVID-19

## Conference call – 16 March 2020

## Present:

- Cllr. Danny Thorpe, Leader of the Council; Takki Sulaiman, Assistant Director, Communities, Cultural and Leisure Services; Cllr. Averil Lekau, Cabinet Member, Health and Adults; Peta Cubberley, VCS Stakeholder Relationship Officer.
- 61 VCS leaders dialled in to the call

## Welcome:

- DT welcomed everyone to the teleconference. Acknowledged the fast-moving events. Noted that the PM had just highlighted how the situation was worse in London than elsewhere in the country. Recommended stopping any non-essential gatherings, based on age, health condition, including pregnant women should shield themselves for 12 weeks.
- Earlier that morning, Council leaders had held a teleconference with the Secretary of State for MHCLG. The key points were:
  - Social care there is extreme pressure and councils need to work with providers. Hospitals are under a period of extreme
    pressure. The situation on testing people for the virus has changed. Now only people going to hospital will be tested.
  - Local government LAs have been asked to coordinate the situation locally. On Sunday, a form was published, and 700 people
    (as of 17th March this rose to over 900) have already signed up as volunteers. Proposals on how to harness the volunteer
    support are being discussed, without the risk of spreading the virus further.
  - Supporting local economy LAs have been asked to coordinate management of a hardship fund but as yet, they don't know how much it is or who it is for.
- Key message is that we want to thank you for your support. This is new territory for all of us. We need everyone to contribute and work together.
- There are some very serious issues being raised in the questions and we will dedicate time to trying to answer them over the next week or so.
- It will take us a while to understand what our position is on some of the matters.
- Thank you for all your comments, and for making us aware of what we need to resolve. We will be working on these issues over the following days, and will get back to you all as soon as we can.
