Keeping Vulnerable Children Safe

Vulnerable Children on a **Child Protection Plan, Child in Need, Looked After Child (Children in our Care)** and children on the edges of social care – know who your vulnerable children are and whether they are being kept safe and check in regularly to ensure their needs are being met.

There is an expectation that vulnerable children who have a social worker will attend their early years setting, so long as they do not have underlying health conditions that put them at severe risk.

In circumstances where a parent does not want to bring their child, and their child is considered vulnerable, the social worker and setting should explore the reasons for this directly with the parent and the setting to consider how to encourage children to attend

Where parents are concerned about the risk of their child contracting the virus, the setting should talk through these anxieties with the parent following the advice set out by Public Health England.

Staying in touch with the parents is part of your ongoing parent partnership and safeguarding duty to children on your roll. Discuss any concerns you have with their social worker, MASH or the Early Years & Childcare team where there is not an allocated social worker yet.

Department for Education (DFE) Update

We are listening to the sector on the challenges faced in providing safe and quality care during the coronavirus (COVID-19) outbreak. We are planning to amend regulations that would allow for the temporary lifting/modifying of a small number of requirements within the EYFS statutory framework, giving settings flexibility to respond to changes in workforce availability and potential fluctuations in demand while ensuring children are kept safe. The proposals, subject to parliamentary agreement, are:

PROPOSALS : During the coronavirus (COVID-19) outbreak only SUBJECT to Parliamentary Approval (not yet agreed)

- use reasonable endeavours to meet learning and development requirements but not be required to do so
- not be required to undertake the progress check at age 2
- ratio requirements will remain as set out in EYFS with flexibility for exceptional circumstances
- use reasonable endeavours to ensure that at least half of staff (excluding the manager) hold at least a full and relevant Level 2 qualification to meet ratio requirements but this will not be a legal requirement
- new entrants will not need to undertake a Paediatric First Aid course within first 3 months to be counted in ratios

Further guidance is due to be issued before the end of April subject to parliamentary agreement of the relevant legislation. Until agreed by Parliament, the current EYFS continues to apply.

News round up from DFE guidance - you might have missed...

- **Childcare practitioners are critical** to the coronavirus (COVID-19) response, so can send their children to school or childcare settings. However, as with all critical workers, many families will be able to ensure their child is kept at home to limit the chance of the virus spreading.
- The DFE states that the scientific advice indicates that educational staff do not require personal
 protective equipment. This is needed by medical and care professionals providing specific close
 contact care or procedures that create airborne risk, such as suctioning and physiotherapy, for anyone
 who has coronavirus (COVID-19) and is displaying symptoms.

The Department for Education Note : Insurance

Business interruption insurance for nurseries that close:

It is important to note that most businesses have not purchased insurance that covers losses from unspecified notifiable diseases, such as COVID-19. Some policies cover losses arising from any disease classed as notifiable by the government, however most policies only cover a specific list of notifiable diseases.

However, for those businesses which do have an appropriate policy that covers Government-ordered closure and unspecified notifiable diseases, the Government's social distancing instructions are sufficient to allow businesses to make a claim against their insurance, provided the other terms and conditions in their policy are met.

The Financial Conduct Authority (FCA) rules require insurers to handle claims fairly and promptly, not reject a claim unreasonably, and settle claims promptly once settlement terms are agreed. In addition, the FCA has said that, in light of COVID-19, insurers must consider very carefully the needs of their customers and show

flexibility in their treatment of them. The Government is working closely with the FCA to ensure that the rules are being upheld during this crisis.

Public liability insurance for nurseries that remain open:

The ABI have discussed this issue as a matter of urgency with their leading and specialist members who write insurance for nurseries and have confirmed that those members continue to offer cover to nurseries that remain open (as well as closed), and who are serving key workers' children as well as vulnerable children, with no change to terms and conditions.

If you have specific examples of cases that you are able to share, you are encouraged to let the local authority know who will pass onto the DFE which is working with the ABI and the Financial Conduct Authority.



The early years and childcare sector is part of a critical national infrastructure providing care for the children of critical workers and vulnerable children. It is crucial that the Department for Education has up-to-date information on what early years and childcare provision exists during the Covid-19 pandemic; which children are accessing it; and any availability or other problems that may be arising.

The DFE and the local authority recognise that you will already be incredibly busy and under significant pressure at this time and thank you in advance for your co-operation in sharing this vital information. It is also a valuable opportunity to highlight the essential role and support you offer families.

Given the rapidly changing situation, the DFE are asking for a short online data collection form to be completed twice a week

Early years and childcare providers to complete survey on Wednesdays and Fridays no later than 5pm

The snap survey is simple and quick to complete – it takes less than 5 minutes if you have your weekly register at hand – and you can complete it on any device including smart phones. Remember to add your setting name in full with Ofsted URN



30 hour codes and funding in Summer 2020

Early years entitlements funding for 2, 3 and 4 year olds will continue to be paid to providers for the whole of the Summer 2020 term – for all PVIs and Childminders there will be an initial 50% advance payment based on Spring 2020 claim and the balance of 50% to be paid on your adjusted return of the pre-populated headcount form. You should have all received your advance payments by now. Get in touch if you haven't eyc-funding@royalgreenwich.gov.uk

Please adjust pupils and state whether they are on roll or in attendance and then return as your final claim when you receive close to headcount date – Thursday 21 May. Please include any children who are temporarily with you where their main provider is closed – remember to add their start dates and ensure you a have parental declaration form for them.

Childcare	All 30 hour codes should have a valid start date that is no later than <u>31 March 2019</u>
Choices	All parents must renew codes as usual – ie every 3 months to be valid.

Review your fee and funding arrangements with parents

The unprecedented circumstances of this pandemic in which the government has requested early years and childcare to close to all children except for children of critical workers and vulnerable children has placed many families and providers in difficult circumstances. The DfE have set out guidance that providers are to be **reasoned, balanced and proportionate** in the dealings with parents given the financial uncertainty they are facing too.

The Department for Education has set out their expectation that settings stay in touch with parents where children are at home.

Many of you have a great parent partnership and are offering lots of support and ideas to parents and carers already. Tell us what you are doing – so we can share with other providers.


