



## **Disability Related Expenditure**

Paying for extra things because you have a disability or illness







**Disability Related Expenditure** is called **DRE** for short.

**DRE** is when you have to pay for extra things because of your disability.



This might be things like:

- Wheelchair insurance
- Telecare
- Gas, electricity and bills



You may not have to pay as much for your care charges if you have to pay for extra things.



We will only ask you to pay less if:

 You can show us you have to buy extra things or services



 We agree you need these things because of your disability



 We think the cost is fair for what you are buying



 You are not already getting money towards the cost from somewhere else. This might be mobility payments, a Direct Payment, or a grant.

## Who can get DRE



To be able to get **DRE** you must:

 Use Social Care Services like support or home help that you are paying for yourself.



- Get disability benefits like:
- Attendance Allowance
- Disability Living Allowance (Care Component)
- Personal Independence Payment (Daily Living Component)



It is really important you tell us about all the extra things you have to pay for because of your disability.



## **Applying for DRE**

At your Financial Assessment we will check if you get disability benefits.



If you do we ask you to pay less for your care charges by a set amount.

We call this a Flat Rate Deduction.



If you get the Flat Rate Deduction you do not have to give us proof of your expenses.



### Our flat rates

There are 2 different rates. Which one you get is linked to your disability benefit.



£10 off a week for people on lower, middle or standard rate disability benefits.



£15.30 off a week if you are on higher rate disability benefit.



You may have to buy extra things and services that cost more than the Flat Rate allowance. If you do you can ask for more money off your care charges.

# Charging for care and support in the home and in the community



At the bottom of the page there is a link to the application form.



If you fill in an application form for **DRE** you will need to show us proof that you pay more.

Proof can be receipts, invoices, contracts or bank statements.



You can still apply if you don't have the proof right away. You have 3 months to show us.

# Extra things and services you can claim for

You can claim for specialist items.

**Specialist items** are things like:

Electric wheelchairs

Stairlifts

Specialist clothes or shoes

Special food you may need











You can claim for adapting or buying your own equipment.



You can claim for running costs for your equipment. This means things like paying for it to be checked, fixed or paying for insurance.



# You can claim for some services:

Carers you pay for yourself



Continence items you buy yourself



Telecare alarm



Cleaning



 Taxis when the cost is more than your mobility benefit



Having shopping delivered



Extra prescription charges

# You can claim for some of your bills:



Heating bill. You may need to keep your house very warm because you can't move about.



 Water bill.
 Your may need to use more water because you have to do lots of washing.



Phone or broadband bill
 You may need to use the phone or broadband to keep in touch with other people.
