## The EU settlement scheme

At present, as a non-UK EU citizen, you can live, work and access services, healthcare and benefits. As we approach Brexit, you will have to apply for new residence status, under the [EU Settlement Scheme](#), which confirms that you live in the UK and have the right to do so. The scheme will allow you to apply to continue living in the UK after 30 June 2021.

What it means:

- If you are an EU citizen who has been a resident in the UK for five years or more, you will be eligible for settled status.
- If you have been a resident for less than five years, you will be eligible for pre-settled status. You will be able to convert this to settled status after five years of residency.
- If you do not apply for settled status by 30 June 2021, you will technically have no legal basis to remain in the UK. The Home Office have not been clear on what the impact of this will be, but you could lose rights to access welfare benefits, support services and wider public funds.
- The deadline for applying is **30 June 2021**.
- There is no cost to applicants and fees will be refunded to those who have already applied.
- UK permanent residents have the right to live permanently in the UK. Permanent residence refers to residence status and does not affect citizenship.

To complete the application you need to use the 'EU Exit: ID Document Check' app (available on Google Play or the Apple App Store) to scan your document and send your photo - you need to use an Android phone, an iPhone 7 (or above) with near field communication (NFC), or a tablet device to do this.

### Book now if you're eligible

#### Who can use this service

You can only use this service if any of the following apply:

- you're aged 18 or over
- you're at [high risk from COVID-19](#) (clinically extremely vulnerable)
- you have a condition that puts you at higher risk (clinically vulnerable)
- you have a learning disability
- you're a frontline health or social care worker
- you get a Carer's Allowance, get support following an assessment by your local authority or your GP record shows you're a carer

If you're an eligible unpaid carer but you cannot book an appointment, speak to your GP surgery.

If you've been invited to book because you're turning 18 soon, please book your 1st dose vaccination on or after your 18th birthday.

The Healthy Start scheme is being extended to children from families with the No Recourse to Public Funds (NRPF) condition.

This change has come about because of a legal challenge bought by a child and their mother living with NRPF. The court ruled that excluding families with NRPF was unlawful because it breaches the duty to safeguard child welfare.

Here is a quote from the child's mother:

*"I have been living with the fear of being punished for needing to have recourse to public funds, and I am glad it is now all over. I hope that other children will not have to grow up in poverty, as my child had to at times, simply because his mum is not British."*

**Zeeba Daycare Royal Arsenal** are proud to announce they are the first ever Nursery, under 5's provision to have gained an Emotion Coaching Accreditation.

Angela Donnelly, manager of Zeeba Royal Arsenal Nursery told us all about their journey

During my journey here we have endured several learning opportunities provided by ICP one being this amazing training to achieve the Emotion Coaching Accreditation.

We started the training in January 2021, starting by training with Sharna Laffey and then with myself and my Emotion Coaching Champions have further guided and implemented various emotion coaching techniques within our daily routine to support our children in how to manage their feelings.

All children's emotions and feelings must be acknowledged and supported correctly. We have created within the nursery environment calming areas, each one tailored for each age group, this is an area where the children can spend a little time with their key person, talk, take time to calm, feel relaxed and be acknowledged. I am pleased to say that the team have successfully embraced the training provided and implement the strategies within the nursery environment consistently.

The Emotion Coaching techniques have had a huge impact on the child's wellbeing which shows across the nursery, linking into PSED. For example with the under 2 year olds they show emotions through their play, the babies express emotions through facial expressions and actions as they explore through sensory play. One toddler expressed how her baby brother makes her sad when he cries. We have found that our children are more confident to talk about how they feel which is fantastic, and seeing that we are taking the time to acknowledge how they are feeling and that's its ok to feel this way is supporting the children to manage their feelings in a more positive way. I am proud to have had the opportunity to be a part of this amazing journey. It has become a part of our everyday practice.

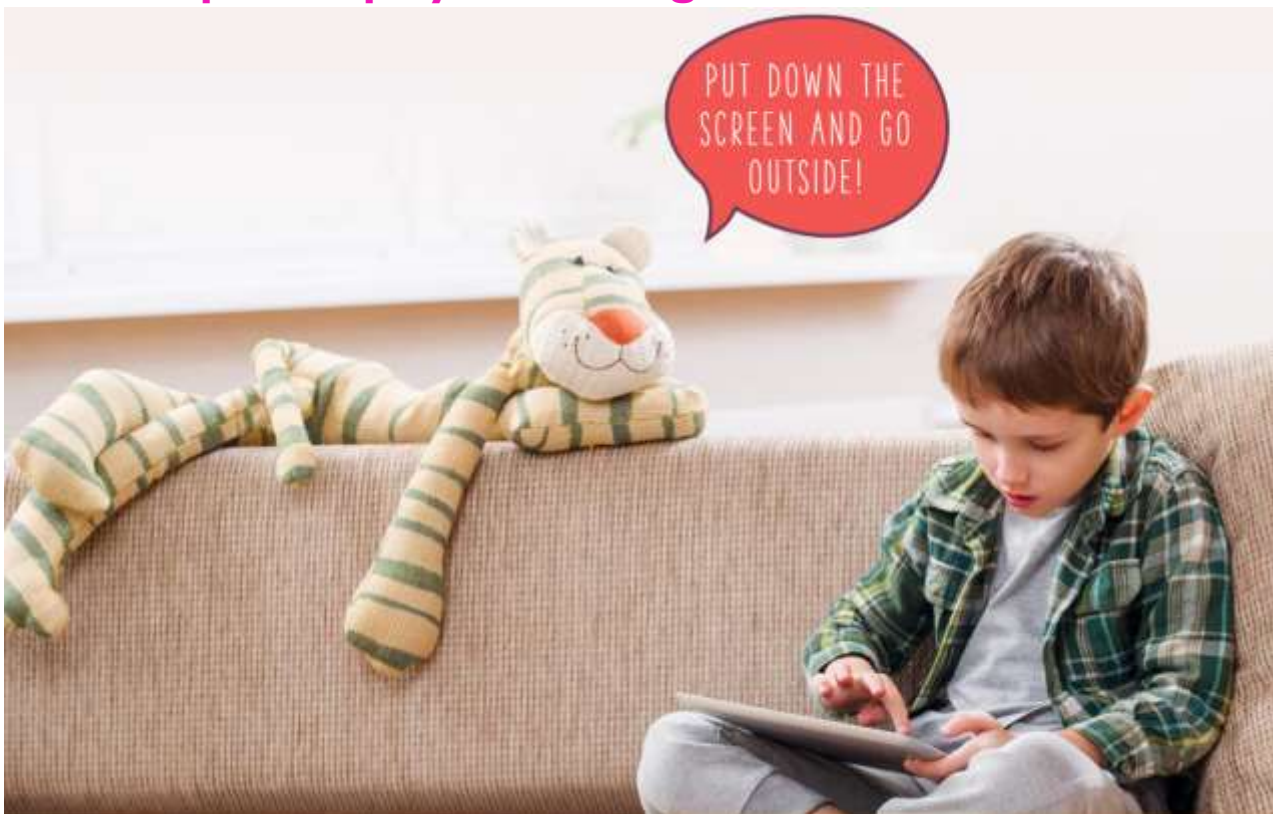

Our gut reaction tells us that too much screen time is bad for kids, depriving them of opportunities for free play, social interactions, eye contact, and direct response from caring adults.

### **Environmental Print is everywhere: look up, look down, look all round!**

The first steps to learning to read are recognising the signs, symbols and logos that have meaning to your child; pointing these out in a fun way will encourage children to recognise print carries meaning. Make it into a fun game in the supermarket, on the high street or on a bus. You will be surprised just how much print you will find!

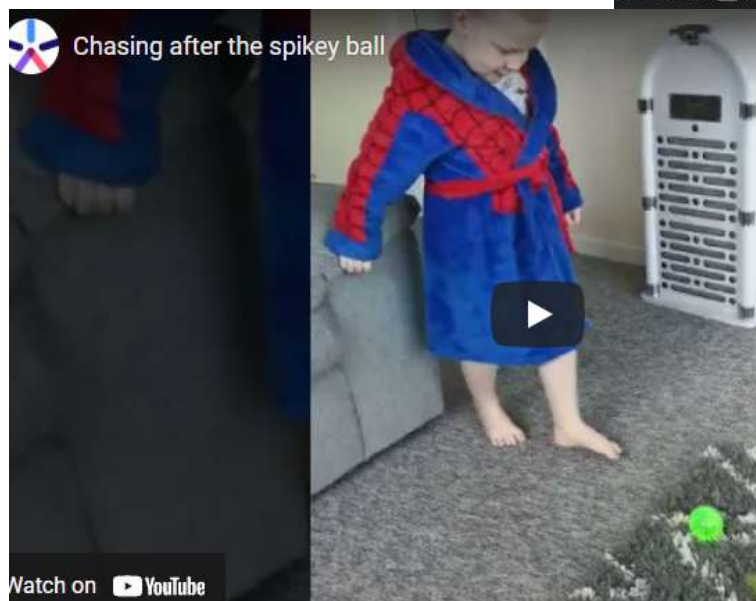

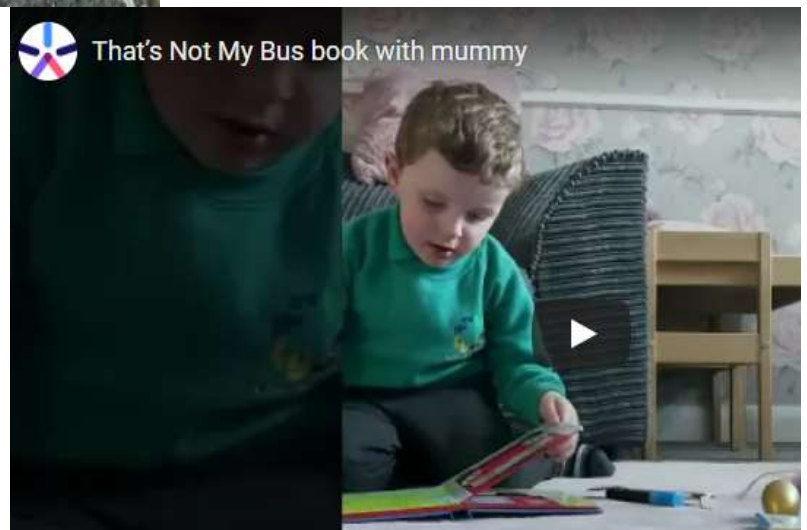


Explore different textures and surfaces with a spikey ball and enjoy talking about them with your child.

## Keeping Children Safe

### DBS Regional Outreach Service – Greater London

The Disclosure and Barring Service (DBS) has launched a new [Regional Outreach Service](#) to focus on working collaboratively with safeguarding and recruiting organisations. The aim is to work closer with organisations and networks to build and develop relationships, acting as a single point of contact for all DBS related enquiries within their region.

Kiran Rehal is the DBS Regional Outreach Advisor for Greater London and will be based in the region. She is available to discuss all matters in relation to DBS, as well as support you and your colleagues in safeguarding and safer recruitment.

Kiran is able to work with you and your organisation in a number of ways, including:

- Answering phone calls or emails to clarify any DBS related queries/questions or advice
- Attending meetings, training, conferences or visiting organisations to have a face to face discussion (in lines with pandemic restrictions)
- Developing and delivering presentations, workshops, webinars or discussions to provide an overview of DBS and safer recruitment
- Taking any feedback, suggestions or comments from DBS experiences and feeding this back into the business
- Helping to understand what level of check can be applied for and what information these checks will provide
- Informing organisations and employers of their duty or power to refer individuals who may pose a future risk of harm within regulated activity. Including an overview of:
  - How to make barring referrals;
  - When should a referral be made and
  - How DBS assess whether a referred person should be included on the Children's and/or Adults' Barred List.
