Benefits and entitlements if you're sponsoring a person/s under the Homes for Ukraine scheme

Introduction

The Royal Borough of Greenwich is committed to providing all the help it can for people fleeing Ukraine. This factsheet aims to support borough residents who are sponsoring people from Ukraine under the government's Ukraine Sponsorship Scheme - Homes for Ukraine (gov.uk/register-interest-homes-ukraine). The scheme has been running since March 2022 so you may be hosting someone for the first time who is already settled in the UK, or the council may have 'rematched' you with a person/s who have left their previous host perhaps because the initial sponsorship period came to an end.

Whatever the circumstances, this factsheet will help you work out how your benefits and entitlements could be affected by taking someone into your home under the scheme, tackle your most pressing questions and provide general reassurance.

The government has said that sponsors who are hosting refugees will not be better or worse off in terms of their benefit entitlements.

We have also listed some key sources of support in the borough for you and the person/family you are sponsoring. Please note that this factsheet is only for residents who are sponsoring people from Ukraine under the Homes for Ukraine scheme. Your questions answered...

How will the 'thank-you' payments affect my benefits?

You will receive a tax-free monthly 'thank you' payment from the government of £350 per month if your guest is in their first 12 months in the UK. The payment will increase to £500 per month once your guest/s have been in the UK for over 12 months, even if you have not hosted before. They are paid in arrears and will not affect any benefits and entitlements you are receiving.

You will need to notify the relevant benefit office/s about your change in circumstances, but the payment will be ignored when calculating Housing Benefit, Universal Credit, Pension Credit, Income Support, income-related Employment and Support Allowance and income-based Jobseeker's Allowance and will not reduce the amount you receive.

Note that thank-you payments are only payable if you are hosting a guest with the agreement of the council. They can continue for up to 2 years if you continue hosting for a longer period.

I receive a single person council tax discount because I live alone - will I now lose it?

No – your 25% single person council tax discount should continue uninterrupted if you accommodate a Ukrainian refugee. Other council tax discounts are also unaffected.

I receive reduced housing costs because I had extra rooms in my home – will I qualify for extra help if I accommodate a Ukrainian refugee?

No – this is because the person/family you are supporting won't be treated as normally living with you. The number of bedrooms considered for you, under the size criteria that's used to calculate your entitlement to Housing Benefit and Universal Credit housing costs, will not change.



I'm on disability benefits and receive a severe disability premium in my means-tested benefits because I live alone – will I still qualify if I take in a refugee?

If you receive a severe disability premium in your benefits (Income Support, income-based Jobseeker's Allowance, income-related ESA, Pension Credit or Housing Benefit), you will not lose your entitlement if you take in a refugee under the scheme as they would be considered as living with you temporarily.

Can I charge rent?

No – you should not charge rent as the sponsorship scheme assumes that the accommodation will be provided rent free. However, you may wish to ask for a reasonable contribution towards food and utilities if you are struggling with the cost of living.

Can the person I'm sponsoring work and claim benefits?

Yes – people arriving under the scheme can live and work in the UK for up to three years and can claim the full range of health benefits, social security benefits and employment support. Where to get extra help/support if you need it

Financial support in an emergency or crisis

The Council's Emergency Support Scheme is a discretionary Greenwich council scheme to assist residents in crisis. Support includes Emergency Support Payments for residents who don't have enough resources to meet essential short-term needs in an emergency or crisis. You don't have to be receiving benefits to qualify. There are also Community Support awards for residents on low-income benefits who need help with one-off items.

If your emergency support payment application is successful, you will be issued with a cash payment which you can redeem at the Post Office.
