

## Foreword





## Introduction

#### About this booklet

This booklet provides useful information on Royal Greenwich primary schools. It shows you how to apply for a Reception place if your child was born between 11 September 2020 and 31 August 2021, and is due to start primary school in September 2024.

You can apply online from 1 September 2023 by visiting **royalgreenwich.gov.uk/admissions** or **eadmissions.org.uk**. The closing date 15 January 2024. Please make sure you apply by this date to ensure that you receive an offer of a school place for your child on National Offer Day on Tuesday I 6 April 2024. If you submit a late application without good cause, you will be sent the outcome after this date.

In this booklet, details are provided on the number of places available at each primary school in the borough, as well as information on how offer decisions are made if more applications are received than the number of places available.

If you would like your child to attend Reception at the same school that they are attending nursery, you must still apply for a Reception place. This is because children do not transfer automatically from nursery to Reception. You must also apply if you have an older child already attending the primary school.

If your child attends an out-borough infant school (for children aged between 4 and 7) you need to apply for a place in a junior school in the same way as those applying for a Reception place. This booklet also provides information on how to apply for a place during the 2023/24 school year.

## The primary co-ordinated admissions scheme

All London boroughs, including Royal Greenwich work together to deliver a co-ordinated admissions process for children moving to Reception or junior school every year. Details of the Pan London Coordinated Admissions Scheme for 2024/25 can be found on our website at **royalgreenwich.gov.uk/ pan-london-admissions** 

As a Royal Greenwich resident, you can apply for a Reception place in any state funded primary school within and outside the borough. You are able to express a preference for up to six primary schools on the Common Application Form (CAF) available online at **royalgreenwich.gov.uk/panlondon-admissions** from I September 2023. Paper applications will only be made available to those who are unable to apply online. Please refer to the Admissions Process section of this booklet on page 60 for further details.



#### Admission terms

The admissions criteria provides the priority order against which applications are considered. If priority needs be be decided between children under a single category, it will be given to those living closer to the school, unless otherwise stated.

#### We recommend that you obtain full details of own admission authority schools' arrangements from their individual websites.

Explanations for the most common admissions criteria used and other useful terminology are provided below.

#### Looked after children and previously looked after children

A 'looked after child' is a child who is in the care of an English local authority in accordance with section 22 (a) of the Children Act 1989. A looked after child is only considered as such if the local authority confirms he or she will be in public care when he or she is admitted to a school.

A 'previously looked after child' is a child who was looked after but ceased to be so because they were adopted or became subject to a child arrangements order or special guardianship order.

If you are applying on behalf of a looked after or previously looked after child, please state this on your application. You will need to provide a letter written by a social worker confirming the child's legal status or an adoption certificate.

Where a looked after or previously looked after child is an unaccompanied minor, a new arrivals age assessment will need to be provided when accepting the offer of a place.

#### Internationally adopted previously looked after children who have been in state care outside of England

A child is regarded as having been in state care in a place outside of England if they were accommodated by a public authority, a religious organisation or any other provider of care whose sole purpose is to benefit society.

If you are applying on behalf of an internationally adopted child who was previously in state care, please state this on your application. You will also need to provide formal written evidence which states that the child was in care or describes the child's pre-adoption circumstances and documentary evidence of adoption. Where applicable this evidence should be translated and certified.

#### Chronic or acute medical or social care need

Evidence of a chronic or acute medical condition or social care need must be submitted with the application.

In most cases, medical or social care needs can be met in any mainstream school. However, if you feel that there is a specific medical or social care reason need why your child should be offered a particular school, you need to state this in your application.

You will need to provide **all** of the following:

- Evidence of the medical condition or social care need e.g. professional medical diagnosis or a statement
- Reasons why your child should attend a particular school, stating the consequences for them or the family member if they have to attend an alternative school
- Documentation from the relevant professional, such as a health or social care professional, which supports your application for a named school on these grounds.

The Medical/Social Admissions Panel for community schools and academies consists of educational, medical and social care professionals and officers from the local authority. The panel meets before offers are made to make decisions based on the individual merits of each case.

Similarly, a request for a place in a school's Designated Specialist Provision (DSP) will only be considered if it is supported by our SEND assessment and review service.

Own admission authority schools will consider each request in line with their published arrangements if they use this criterion. The Department for Education has produced statutory guidance called "Supporting pupils with medical conditions at school". A copy can be obtained at gov.uk/government/publications.

#### Sibling

Sibling means a full, half, step, adopted or foster brother or sister. This does not include siblings attending a school's nursery provision.

If you have an older child or children already attending the school, you need to make this clear on your application.

#### Children of staff

Eligibility under this criterion varies, but may include; employed on a permanent contract, and/ or employed at the school for at least two years at the time of application and/or been recruited to fill a vacant post for which there is a demonstrable skill shortage.

The school's governing body or board of trustees will approve any decision to prioritise places according to this criterion.

#### Distance

Distance from home to school is measured as a straight line from the centre of the home address to the centre of the school site.

In the event that two or more applicants have equal right to a place under any of the criteria, priority will be given to those who live nearest to the school,

- 2. Baptised Catholic children of a practising Catholic parent or carer, as verified by reference from the priest of the parish where the family regularly worships. Priority will be given to those who reside in the Parish of St John Fisher and St Thomas More, Eltham Well Hall.
- 3. Children enrolled in the catechumenate.
- Other looked after and all previously looked after children, including those children who appear to have been in state care outside of England and ceased to be in state care as a result of being adopted.
- 5. Children who are members of Eastern Orthodox churches in union with Rome.
- 6. Children of committed members ofother Christian denominations.
- 7. Children of other faiths whose parent or carer is in sympathy with the aims and ethos of the school and whose application is supported by a religious leader.
- 8. Any other children.

The following order of priorities will be applied when it is necessary to decide between applications within any of the above categories:

- i. For category 2, the evidence of strength of commitment to the faith, as demonstrated by the level of the family's Mass attendance on Sundays
- ii. For categories 4, 5 and 6, the evidence of strength of commitment to the faith, as demonstrated by the level of the family's attendance at services.
- iii. Children with a sibling, living at the same address, attending the school at the time of admission.
- iv. Children with an exceptional and professionally supported medical, social or pastoral need for a place at the school.
- v. Distance from home to school.

## Admission into Reception class in September 2024

## Making your application

Children born between I September 2020 and 3 I August 2021 will start school in September 2024. This is not an automatic process and so you will need to apply for a Reception place for your child.

You can apply for schools in any area, but if you live in Royal Greenwich you need to make your application through us. If you live in another borough, you need to make your application through your home authority even if you wish to apply for a place in a Royal Greenwich school.

If your child attends the nursery provision in a primary school and you would like them to be considered for a place in the school's Reception class, you must make an application. However, please bear in mind that, as attendance at a school's nursery is not part of the decision making process, there is no guarantee that your child will be offered a Reception place at that school.

Some boroughs have infant and junior schools. If you live in Royal Greenwich and your child attends Year 2 in an infant school in another area, you will need to apply through us for a Year 3 place in a junior school. To be eligible to apply for entry in September 2024, your child needs to have been born between I September 2017 and 31 August 2018.

#### Special educational needs

If you live in Royal Greenwich and your child has an Education, Health and Care (EHC) Plan, you need to apply through a separate process.

Further information about special needs provision in the borough and how to apply is available on page 68. Our SEND Information, Advice and Support Service supports families of children with special needs. The service offers information, advice and guidance so that you can make an informed decision regarding your child's education.

#### Applying online

Some of the advantages of applying online are:

- it is quick and easy to use
- the online system is open from I September and is available 24 hours a day, seven days a week
- there is no risk that your application will get lost or delayed in the post
- you will receive confirmation that your application has been submitted successfully
- you will get the result earlier no waiting for your letter to arrive

If you are unable to apply online, a paper form can be sent to you on request by emailing **schooladmissions@royalgreenwich.gov.uk**. A PDF document will then be emailed to you to print off and complete. If you are sending your form back to us, please check that you have used the correct postage so that it does not get delayed in the post and be aware that we do not acknowledge receipt of your application. If your application arrives after the closing date, it will be treated as a late application.

# Application guidance notes

## Please read the following carefully as it contains important information.

We hope you find the application guidance notes useful when completing your application. However, if you need additional support, our Families Information Service can help. This service is available to everyone and provides:

- a wide range of information on local primary schools
- support in making informed and realistic preferences
- help in completing the relevant forms
- information about the appeals process

#### Parent or carer's details

To make an application, you must have parental responsibility for the child. For address verification purposes, it would be helpful if you are also a named person registered to pay Council Tax at your address.

If you are not the child's parent, you will need to provide proof of guardianship such as a child arrangements or a court order. If you are applying online, you can submit this electronically. If you are sending a hard copy, please do not include original documents.

#### Home address

This must be a Royal Borough of Greenwich address and is where your child resides as their only or principal residence. If your child resides equally between both parents, we consider the principal home address as being the address at which your child is registered whilst attending early years provision, with a GP and, if applicable, the address of the parent who is in receipt of state benefits for your child.

#### Proof of address

- You do not need to provide proof of address if you registered to pay Council Tax or receive Council Tax benefit for the property if it is in Royal Greenwich
- We will check our Council Tax records to confirm that the address you have given on your application form is your principal home address.
- If you are not registered to pay Council Tax, either because you are not liable or have recently moved, you will need to provide **one** of the following as proof of your address:
- opening accounts for public utilities such as electricity, gas or water
- a tenancy agreement via a commercial letting agency (the tenancy period must extend beyond the start of the academic year in which your child starts primary school)
- proof of payment of rent to a landlord on a regular basis
- evidence of completion of the purchase of a new property on or after the date of completion.
- If you are unable to provide any of the above documentation, it is important that you seek advice from us. If you are not listed on our Council Tax records and do not provide the relevant proof, your application will not be processed.

#### **Overseas** applicants

If you live overseas, we will process your application using your future Royal Greenwich address, pending



satisfactory evidence of your relocation date and address. Evidence of your future Royal Greenwich address could include:

- a mortgage or commercial rental agreement for a property in the borough
- deeds for a property in the borough
- a letter from an employer on headed paper showing a transfer date to the area

If you are unable to provide evidence of a future Royal Greenwich address, we will process the application from your current overseas address. However, we will require evidence before the school year or term begins to confirm that your child now lives in the borough. This could be in the form of:

- boarding pass or flight details for your child's journey to the UK
- written confirmation of registration with a local GP

If this cannot be provided and/or your child does not start on the date agreed with the school, we may withdraw the offer and allocate the place to another child.

#### Military families and Crown servants

Members of the UK armed forces and Crown servants should provide details of a 'posting' or 'quartering' address in the borough, in the absence of an actual home address.

#### False or misleading information

School places are offered on the basis of the principal home address. Unfortunately, some parents and carers supply false or misleading information on the application form, hoping that it will increase their chances of being offered a place at a particular school. For example, they claim to live at the address of a relative rather than at their principal home or give the address of a property rented for a period of time before returning to their principal home. This could result in a child who should have been offered a place at that school being deprived of it.

Our application forms contain a statement that the information supplied is true and that providing false or misleading information may render the application invalid. By submitting an application, you are agreeing to this. In establishing your principal home address, we will check records held within the Council and with external agencies. Where there is suspected fraud, we will require applicants to provide additional evidence and the case will be referred to our Internal Audit and Anti-Fraud Team for investigation.

If we find that an application was made on the basis of false or misleading information, it will be withdrawn from the primary admission process. It will be treated as a late application using the principle home address.

If an offer of a school place is made on the basis of false or misleading information, we will withdraw the offer. This may be after the child has started at the school.

#### Change of address

If you move address within Royal Greenwich after submitting your application, you must let us know in writing no later than four weeks from the date of your move and by 8 February 2024. We will require proof of your new address. You can do this by emailing us at school-admissions@royalgreenwich. gov.uk.

If you move to a new address without telling us, and secure an offer of a school place based on your old address, we shall consider this as being misleading information and the offer will be withdrawn. Your application will be reconsidered on the basis of your new home address.

If you move to our borough from another area on or before 8 February 2024, your previous home authority will forward your application to us so that we may take over responsibility.

If you move into Royal Greenwich after this date, your application will remain the responsibility of the local authority in whose area you lived when you made your application. We will take over responsibility after 16 April 2024.

If you move out of Royal Greenwich to another area after submitting your application to us, you should also contact your new home authority to obtain details of their arrangements.

#### School preferences

You can apply for up to six primary schools, listing them in preference order. If your child currently attends an infant school and needs to transfer to a junior school, you can name three preferences. You can also state the reason for each preference should you wish to do so.

Before deciding on your preferences, you should consider each school's admission criteria and the previous year's application rates to see whether your child is likely to be offered a place.

Although it is for you to decide on your preference schools, your preferences do need to be realistic. We recommend that you do not 'waste' a preference by naming a school at which your child is unlikely to be offered a place.

Your preference schools can be in Royal Greenwich or in other areas, but not independent schools. If you wish to apply for schools in other areas, you should contact the local authority in which the school is situated for details of their procedures and timetables.

You do not have to list six schools, but the more schools you list, the better your chances of being offered a place at one of them.

Please do not list a school more than once. Your child can only be considered once for each school, so any duplicate lower preferences will be deleted.

If you are applying for a place at Bannockburn, Heronsgate, Invicta, James Wolfe, Plumcroft, St Thomas a Becket RC or Windrush Schools, you may not specify which site you would prefer your child to attend. For further information on how decisions are made for schools split over two sites, please see page 49. As any preference may be offered, you should not name a school that you do not wish your child to attend. If you are applying for a place at St Mary Magdalene CE School, you need to complete a supplementary information form specifying which site you are applying for.

While there is no guarantee that your child will be offered a place at any of your preference schools, we

recommend that you include schools nearest to your home address. If you do not, and it is not possible to offer you one of your preferred schools, your child may be allocated a school much further away.

Please make sure that you have ranked your preferences in the order you genuinely want them to be considered. Any changes you wish to make to your preferences after the closing date will only be considered once all applications, including those submitted late, have been processed. This is likely to be from June 2024 onwards.

#### Offer of a place

Each of your preferences will be considered individually under each school's admission criteria.

If more than one offer can be made from your list of preferred schools, we will check your application to see which one is ranked highest and offer you that place. If only one school can be offered from your list, this is the school we will offer. Any schools listed as a lower preference will be automatically withdrawn so that these places can be offered to other applicants.

If it is not possible to offer any of your preference schools, your child will be allocated a place at the nearest school with a vacancy. Please bear in mind that the allocations process is based solely on distance. This means your child could be allocated a place at any school.

If you applied online, you can log on to eadmissions.org.uk during the evening of 16 April 2024 to view the outcome of your application.

Go to eadmissions.org.uk to see the outcome of your application.

#### Accepting the offer

If your child is offered a place at a preference school, we will assume that you wish to accept this offer and record this as such. In the unlikely event that you do not wish to accept the offer, you will need to let us know. You can do this by emailing us at

school-admissions @royalgreenwich.gov.uk.



If you have been allocated a school, you will need to let us know if you wish to accept or decline this offer. The simplest way to do this is by emailing us at school-admissions@royalgreenwich.gov.uk.

Alternatively, if you applied online, you can respond via the eadmissions portal at **eadmissions.org.uk** or if you applied using the paper form, complete and return the reply slip attached to your notification letter.

You need to respond by 30 April 2024. If you do not respond by this date and we can show that every

You need to respond by 30 April 2024. If you do not respond by this date and we can show that every reasonable effort has been made to contact you, the offer will be withdrawn.

If you do not accept the offer, you will need to confirm what alternative arrangements you are making for your child's education.

#### Deferred entry

If you feel that your child is not ready to start school in the September following their fourth birthday, you can arrange for your child to attend part-time until they reach statutory school age, or defer the date that your child is admitted to the school until later on in the Reception year. If your child's entry is deferred, the school must hold your child's place and not offer it to another child.

If you wish to defer your child's entry, you will need to confirm this with the primary school where your child has a Reception place. You also need to confirm this with the early learning provider so that your child can continue to receive their free early learning entitlement.

## Admission of children outside their normal age group

If you would like to request for your child to be educated outside their normal age group, you must still make an application for a school place. You will need to put your request to us separately, in writing. You may also provide supporting documentation, should you wish to do so. The admission authority for each of your preference schools will make a decision based on the individual in line with current DfE guidance. They will take account of your views; information about your child's academic, social and emotional development; their medical history and the views of a medical professional, if applicable, and whether they have previously been educated outside their normal age group. The admission authority will also take into account the views of senior staff within the school and other professionals.

Current DfE guidance does not suggest that children who are already attending school are educated outside of their normal age group purely

on the basis of them not attending an education setting during the COVID-19 pandemic.

You will be advised, in writing, of the decision regarding which year group your child should be admitted to and the reasons why this decision was reached. If your child is summer born and the admission authority has agreed that they can be educated in a younger year group, you will need to re-apply for a place for September 2025. As there is no guarantee that it will be possible to offer your child a place at a particular school, you are advised to have alternative arrangements in place.

If the admission authority does not agree to your request for your child to be educated outside the normal year group, there is no formal right of appeal.

#### Late applications

Applications received after the closing date but by 8 February 2024 may be treated as being late with 'good cause', if family or other circumstances made it impossible to apply by the closing date. An application submitted late with 'good cause' is treated at the same time as those applications submitted on time. Examples of 'good cause' include where a single parent or carer has been seriously ill during the application period, there has been a recent death in the family, or if a family has just moved into the area. You need to state the reason you are applying late, providing documentary evidence where possible. We can then assess whether your application should be treated as late with 'good cause'.

Late applications, received by 8 February 2024, that are not late with 'good cause,' and any applications submitted after this date, will be considered from June 2024 onwards.

The online system closes on 10 August 2024. If you are submitting your application after this date, your application will be considered as an in-year application. Please refer to page 66 on how to make an in-year application.

#### Waiting lists

Waiting lists are maintained in the same order as the published admission criteria. Priority is not given on the basis of when a child's name was added to the list or whether an offer of an alternative school has been accepted. This means that a child's position on a school's waiting list can move up or down the list. Your child's name will automatically be added to the waiting list for any school you listed as a higher preference than the school offered. This also applies if you are not offered any of your preference schools.

To use our online waiting list checker for academies and community schools, go to **royalgreenwich**. **gov.uk/admissions**. Voluntary aided schools can be contacted directly for details of their waiting lists.

If you do not want your child's name added to a school's waiting list, you will need to let us know. You can do this by emailing us at school-admissions@royalgreenwich.gov.uk.

All Royal Greenwich schools maintain a waiting list until the end of August 2024. If you would like your child's name to remain on the waiting list for the following academic year, you will need to re-apply.

Please check individual school's arrangements for further information.

#### Appeals

You have the right to appeal against the decision not to offer your child a place at any school you listed as a preference. However, we expect that you will only

#### appeal for a place at a higher preference school.

With regard to Bannockburn, James Wolfe and St Thomas a Becket RC Schools, you may only appeal if your child has not been offered a place at the school. There is no right of appeal against the decision not to offer a place at a particular site.

If you applied for a place at Heronsgate, Invicta, Plumcroft or Windrush Schools and your application was considered under the distance criterion, you may only appeal for a place at the site nearest to your home address.

St Mary Magdalene CE School has similar arrangements. Further information is available from the school.

## To appeal go to school admission appeals at royalgreenwich.gov.uk/admissions

If you wish to appeal against a decision not to offer your child a place at a community school or academy, you need to complete our appeal form stating your reasons for appealing against the admission decision. To appeal online and obtain guidance notes on the appeals procedure, go to **royalgreenwich.gov.uk/ admissions**.

If your child has not been offered a place at a voluntary aided school, you will need to complete an appeal form provided by that school.

All appeals are heard by an independent appeal panel in accordance with the Schools Standards & Framework Act 1998.

The law states that infant classes must not have more than 30 pupils. This means that independent appeal panels have limited powers to allow an appeal.

#### Of the 25 appeals for primary community schools and academies for entry in September 2023, none were successful

The deadline for submitting an appeal form is 14 May 2024, so that hearings can take place in June and July. If you submit an appeal form after this date, it is possible that your appeal will not be heard before your child is due to start school in September.



The following information only applies if your child is already primary school-aged and you are seeking a primary school place within the borough during the 2023/24 academic year.

#### In-year admissions

Royal Greenwich is the admission authority for all community primary schools in the borough and therefore coordinates their in-year admissions process.

Due to a local arrangement with primary academy schools, Royal Greenwich also co-ordinates the in-year admissions process for all primary academy schools.

To see a flowchart of the in-year admissions process, go to **royalgreenwich.gov.uk/admissions**.

Voluntary aided schools manage their own in-year admissions and so you will need to apply to them directly.

Please see pages 44-45 to find out the admission authority for each school.

An in-year application for community and academy primary schools can be submitted through the Parent Portal at greenwich.cloud.servelec-synergy. com/ParentPortal. If you are unable to apply via the portal, please request a paper form via: schooladmissions@royalgreenwich.gov.uk. We will email a PDF document to you, for you to print off and complete.

Admission decisions are made using the criteria set out in our booklet Primary Schools in Royal Greenwich 2023/24. A PDF copy of the booklet is available at **royalgreenwich.gov.uk/admissions** under the archive section.

If we are unable to offer a preference school and you live in Royal Greenwich, your child will be allocated a place at the nearest school with a vacancy in the relevant year group. In some instances, we may offer an alternative education placement if it is best suited to your child's needs. If you would like your child to be considered for schools in other areas, you need to contact the local authority in which the school is situated to find out how to apply.

#### School transfers

Changing schools can be disruptive and may not be in your child's best interests. We recommend that, before requesting a transfer, you discuss your reasons with senior staff at your child's current school. They will be happy to discuss your concerns and help resolve any issues.

#### Fair Access

We have a Fair Access Protocol (FAP) to ensure vulnerable children struggling to secure a school place through the usual in-year admissions process get a suitable school place as soon as possible.

FAP may only be used to place 'eligible children' outside of the usual in-year admissions process. This means that FAP may only be used as the last resort after all efforts to secure a school place have been exhausted without success.

## **Additional information**

We offer a range of services to assist children in getting the best out of their education. The following section gives brief details of some of these support services and where to go for further information.

#### Extended schools childcare

Extended schools childcare is care for schoolaged children, and supports parents and carers so that they are able to work or attend education or training. It includes breakfast clubs, after school clubs, registered childminders and holiday play schemes.

Breakfast clubs offer children the opportunity to play, meet friends and have breakfast before school in a supervised setting. Most Royal Greenwich schools can offer children access to a breakfast club. They usually open at 8am (although some start earlier) and are only available during school term time. Breakfast clubs can be based at a school site or in other local premises and may have children from more than one school attending. Formal supervised escort arrangements will be in place to ensure that children arrive safely at their own school if the club takes place somewhere else.

After school clubs offer children the chance to play, do their homework and relax with friends in a supervised setting. Most Royal Greenwich schools can offer children access to an after school club, on-site or at a nearby venue. After school clubs start at the end of the school day, when younger children are collected from their teacher and older children make their way to the play club. All children attending a club that is not on their school site will be transferred by a formal supervised escort.

Registered childminders can offer a before school, after school and holiday childcare service, in a home setting that has been assessed to ensure it is safe for children. They can care for school-aged children and their younger siblings in one place and may be able to provide extended hours of care. Registered childminders have undertaken training and can offer a flexible childcare service.

Holiday play schemes offer day care for children of school age during the holidays. They usually open at 8am and close at 6pm, although times can vary.

Further information about all the extended school childcare services in Royal Greenwich, including the schools that they deliver to and collect from, registered childminders and childminder places, and holiday play schemes is available on our website.

#### Free school meals

All children in Reception, and Years 1 and 2 are entitled to a free school meal. Contact your child's school for further information.

If your child is in Year 3 or above and you receive a qualifying benefit, your child may be eligible for free school meals. The qualifying benefits are:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under part six of the Immigration and Asylum Act 1999
- Child Tax Credit only (provided you are not entitled to Working Tax Credit and your annual income does not exceed £16,190)
- Pension Credit Guarantee
- Universal Credit with an annual net income of no more than £7,400
- Working Tax Credit run-on (paid for four weeks after you stop qualifying for Working Tax Credit)

You may also be eligible for free school meals if you have nil recourse to public funds (NRPF). Please contact the NRPF Team who are able to provide statutory services to Royal Greenwich migrant residents who are experiencing destitution. If your child was in receipt of free school meals on 31 March 2018 they should continue to receive free school meals until the end of the universal credit roll out period, and then until their phase of education ends.

This covers until at least summer 2025, and applies even if where family circumstances change and your child would no longer meet the eligibility criteria. This does not mean that a sibling joining the school is automatically eligible. You will need to apply for them.

#### School milk

Many primary schools provide one third of a pint of milk to their pupils. Your child will get this free if you are in receipt of either Income Support or Incomebased lobseeker's Allowance. Contact your child's school for further details.

#### **Travel** assistance

All children and young people under the age of 19 who are in full-time education can travel free on London buses and trams.

For details about eligibility and application forms, please go to Transport for London's website at tfl. gov.uk or contact the Oyster Card helpline on 0343 222 1234.

The majority of children with special educational needs and disabilities (SEND) do not receive specialised travel assistance from Royal Greenwich. It is expected, wherever possible, that parents of children with an Education, Health and Care (EHC) Plan will make arrangements for their child to attend school in the same way as for parents of children without an EHCP, as this is an important factor in developing the child's independence, social and life skills.

Travel assistance to and from school may be provided for children with an EHCP who are unable to use public transport because of their special needs. We may also offer travel assistance to children where a medical condition prevents them from using public transport.

In exceptional circumstances, children who do not have an EHCP or a medical condition may also be entitled to travel assistance.

#### Special educational needs and disabilities

Most children with special needs will not have an Education, Health and Care (EHC) Plan, and so will apply for a primary school in the same way as any other child starting school.

We provide a range of specialist services to support children with special needs in our schools and they achieve excellent outcomes.

We also have mainstream schools with Designated Specialist Provision (DSP). Children spend some of their time in the DSP, depending on their needs, accessing the specialist resources within them. Depending on the area of need, different professionals will be on site to deliver support.

We have DSPs in primary schools for children with Autistic Spectrum Disorders (ASD), and for children who are deaf or have a hearing impairment.

Places in DSPs are agreed by the SEND Assessment and Review Service via the DSP Panel.

Our Local Offer sets out the services for children with special needs and disability that are available in their school or area. As support services may differ between boroughs, we advise you to consider the Local Offer for the borough in which schools are based before deciding on your preferences.

To help you consider options for your child starting primary school, and for information on SEND admissions criteria, go to royalgreenwich.gov.uk/localoffer.
