The premises operates as an off-licence and general store selling groceries, household goods, newspapers and magazines, etc. It has held a premises licence authorising off-sales since August 2005, when a former Justices' Licence was converted from the now-repealed Licensing Act of 1964. The current hours are 08:00 hours to 23:00 Monday to Saturday, and 10:00 hours to 22:30 on Sunday (with bespoke hours for Good Friday and Christmas Day). It is proposed that the existing licence be formally surrendered if this current application is granted.

In terms of Late Night Refreshment, this is proposed to be takeaway microwaveable foods such as pies, savouries, soup, etc – plus the provision of tea, coffee, and such like.
